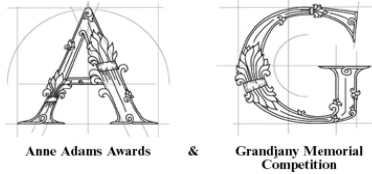


The American Harp Society Foundation Awards



May 30, 2024 Grandjany Memorial Competition Application

Application Deadline: **April 5, 2024**

Applications will be accepted from advanced students who are:

- Members of the American Harp Society
- Age 35 or younger as of April 5, 2024
- Past winners of the Marcel Grandjany Memorial Competition are ineligible to compete.

1. PDF of your application
2. For Prescreening: a link (or several links) to unpublished/private Youtube video(s) of the required pieces. (Recordings do not have to be completed in one sitting for all pieces, nor do they have to be professionally recorded. A smartphone recording from a quiet room is sufficient.) Please entitle the tracks with your first initial & last name & first word of piece (“ASmithFantaisie” or “ASmithDans”).
3. For Prescreening: mp3 recordings extracted from the video(s) of the required pieces Please entitle the tracks with your first initial & last name & first word of piece (“ASmithFantaisie” or “ASmithDans”).
4. a current resumé
5. a headshot AND a current bio (500 words or less) for use at the AHS National Conference and any publicity done for the Anne Adams Awards and Grandjany Memorial Competition, and the American Harp Society and American Harp Foundation, including websites
6. any current works you would be prepared to play on the Winners’ Recital, details TBA., besides the required pieces
7. \$45 application fee (see below)

The award is \$3500, drawn from the Grandjany Memorial Fund housed in the American Harp Foundation.

The American Harp Foundation is pleased to announce that the 2024 **Marcel Grandjany Memorial Competition** (May 30) will take place on May 30, 2024, at Mason Gross School of the Arts, Rutgers University, in New Brunswick, NJ. The competitions will conclude with the winners’ recital on the evening of May 30, which will be open to the American Harp Society, the Rutgers community, and the public. Rutgers is located 25 minutes from Newark Liberty International Airport and is accessible by train from New York City. More information about local hotels and accommodation will be provided to applicants.

Competitors will perform in **Nicholas Music Center**. This 704-seat music hall serves as the largest performance space on campus. Designed by the distinguished architect Pietro Belluschi—whose roster of other projects includes Alice Tully Hall in New York City, the Davies Symphony Hall in San Francisco, and the Meyerhoff Symphony Hall in Baltimore—the center was built in 1981 and underwent extensive renovations in 2018.
